Eligible entrants	 Entry is open to residents of Australia over the age of twenty-one (21) years old, who hold a valid full-drivers licence. Entrants are required to provide personal information to the Promoter. The Promoter does not knowingly collect personal information from persons under the age of 21. Such persons are expressly prohibited from submitting their personally identifiable information to us and any information submitted by such users will not knowingly be used, posted, or retained by us. Employees of the Promoter and their respective subsidiaries, affiliates, officers, agents and the immediate family members are not eligible to participate in the Competition. Proof of identity must be furnished upon request.



Details of prize/s	 One (1) Winner will be drawn via a random electronic draw at 24 Lindus St, Wickham, Newcastle, NSW 2293 at 10.00am on 29 February 2024 ("Prize Draw Date"). The Winner can choose to claim their prize at either the Toowoomba or Bendigo Meatstock 2024 event (one event only). The Toowoomba event is 3 x days and the Bendigo event is 2 x days. The prize entitles the Winner to the full weekend tickets to the event of their choosing, as well as Camplify accommodation for the duration of the event. Camplify accommodation to the Toowoomba event is for the 3 days of the event to a maximum value of \$700. Camplify accommodation to the Bendigo event is for the 2 days of the event to a maximum value of \$500. The process outlined in clauses above will be repeated until a winner is contacted and accepts the Prize (allowing for the time frames to be adjusted).

If the winner is unable to attend the camping festival, they may transfer the prize to another individual of their choosing. The winner must notify Camplify of the transfer in writing by 12:00pm on 02/03/2024.
